11/6/2021: Future Leaders Steering Committee: following the successful webinar, EFCA FLs wish to leverage their network and intensify activities

14/6/2021: FIDIC Regional Chairs meeting: the Chairs of the regional groups (FIDIC Africa, FIDIC Europe and FIDIC Asia-Pacific) give a short overview/presentation about their region. Announcement of the formation of FIDIC North America, bringing together ACEC (United States), ACEC (Canada) and CNEC (Mexico)

15/6/2021: Digitalisation and BIM Committee: the EU BIM Task Group, representing Europe's public clients and public sector procurers, invites the chair to present our industry's issues. EFCA and ACE (Architects), will send a joint letter to DG GROW, setting out the challenges for the European design community regarding data accessibility and ownership, intellectual property and interoperability

16/6/2021: **ECCREDI** (European <u>Council</u> for Construction Research, Development and Innovation) Meeting: update on the new European Bauhaus and the EU Taxonomy

17/6/2021: **European External Action** Committee: the Committee's new name is adapted to its extended scope, entailing both aid and financial resources from the development banks.

Topics of discussion included the involvement of FLs in helping to profile the industry's contribution to sustainable development and green growth, the advocacy of the need for more TA funding and the use of TA funds for project preparation, and how to strengthen the industry arguments in the dialogue on PRAG with DG INTPA

21 & 25/6/2021: the Chairs of the European Development Action, European Green Deal and Internal Market Committee meet with EIC (European International Contractors) on the development of a possible joint EIC / EFCA Toolkit on Sustainable Procurement

1/7/2021: second public <u>event</u> organised by the **Construction 2050 Alliance**, showed that construction is a sector that can offer many opportunities to new talent

8/7/2021: the four working groups of the **European Green Deal** Committee (Climate Adaptation; Circular Economy; Sustainable Mobility and Renewable Energy) present their action plans, which they elaborated over the past period

9/7/2021: EFCA and the Architects' Council of Europe (ACE) jointly elaborated a position paper on the **relationship between users and software companies/editors/service providers**, based on the FIEC paper issued last year
