European Central Bank (ECB) survey report on the **Access to Finance of Enterprises** (SAFE): small businesses report challenging outlook for their access to external financing due to COVID-19

On 8 May, the Commission announced a further adaptation of the **rules on state aid** to provide a framework for recapitalisation and the use of aid instruments for firms in difficulty. The Commission will extend the easing of the rules until the end of 2020. Under the EU's updated regime, support will come "with strings attached," including a ban on dividends and bonus payments to managers of companies receiving financial support. There are no specific green requirements – only an obligation to report on how taxpayer money is used for the green and digital transitions.
